
ETHANOL PRODUCTION REPORT September 6, 2012


Summary

Ethanol production for the ending week August averaged 829 thousand barrels per day. This is up 1.22% vs. last week and down 7.48% vs. year. Total Ethanol production for the week was 5.803 million barrels. Stocks as of August 31 were 18.732 million barrels. This is up 1.29% vs. last week and up 9.66% vs. last year. Corn used in last week's production is estimated at 88.31 million bushels. This crop year's cumulative corn used for ethanol production for this crop year is 4.96 billion bushels.


