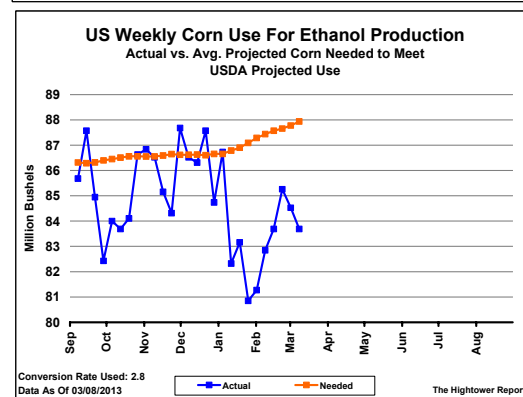
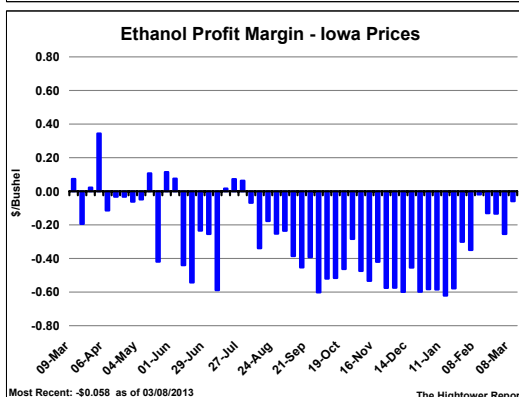
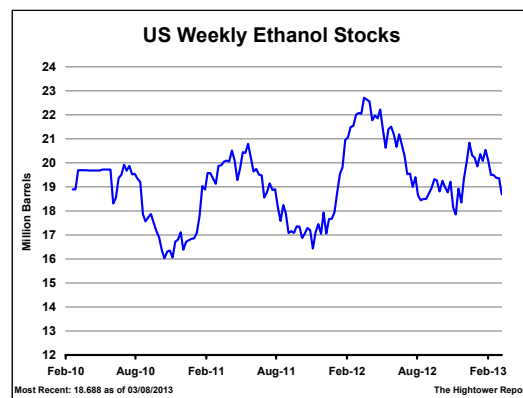
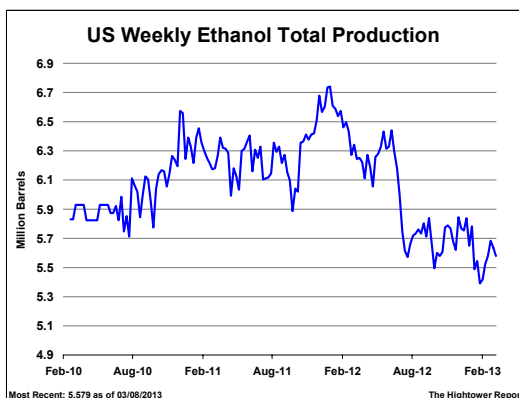
Summary

Ethanol production for the week ending March 8 averaged 797 thousand barrels per day. This is down 0.99% vs. last week and down 10.65% vs. last year. Total Ethanol production for the week was 5.579 million barrels. Stocks as of March 8 were 18.688 million barrels. This is down 3.43% vs. last week and down 15.22% vs. last year. Corn used in last week's production is estimated at 83.69 million bushels. This crop year's cumulative corn used for ethanol production for this crop year is 2.29 billion bushels. Corn use needs to average 87.938million bushels per week to meet this crop year's USDA estimate of 4.5billion bushels.
